Any breach of confidentiality will be considered as a breach of this agreement.

Cancellation

In the event of illness, accident or death, including that of immediate family members, preventing The Artist from appearing, the Promoter will be informed at the earliest opportunity and if required by The Promoter a medical certificate shall be provided forthwith.

Fancourt Music is not responsible for any non-fulfilment of contracts by artists however every reasonable safeguard is assured.

If the Promoter cancels this contract, the following fees will apply:

More than twelve weeks before the show date: 50% of the fee;
Between twelve weeks and four weeks before the show date: 75% of the fee;
Less than four weeks before the show date: 100% of the fee.

This Agreement shall be construed in accordance with English Law and each party hereto agrees to submit to the exclusive jurisdiction of the English Courts.

This contract together with the attached rider and technical requirements form the agreement and cannot be modified or cancelled except by mutual consent in writing from both parties.

ADDENDUM

Cancellation outside the reasonable control of the Purchaser or the Artist

In the instance of an occurrence caused by circumstances outside the reasonable control of the organiser resulting in the cancellation of the event, including without limitation; an act of God, act of terrorism, material threat of an act of terrorism, fire, flood, explosion, civil commotion or disturbance, war, storm, earthquake, strike, lock-out, or other industrial action, insurrections or riots, pandemic or epidemic, change in law, prohibition or imposition of requirements by any governmental body, any deposits paid by the organiser will either be refunded to the organiser or, upon agreement of the parties, rolled over to the organiser's next event and any fees due shall not be payable.
